The Project. We completed a 6 week review that included managing workflows, TAR analysis, QC and production of 6 million documents for 20+ custodians. It began with 2 weeks of working through a privilege log of 60k entries, followed by a refresh of collection review, qc and production. Ongoing productions started during the second week of review. Finally, we partnered with an EDD hosting vendor and created a seamless process involving multiple checkpoints to stay on track.

The Results. The review was finished on time and under budget. Over 10 million documents were reduced to just over 6 million, with a reduction rate of 40%. The team also met a very aggressive deadline, including the deadlines for extensive redactions and a voluminous privilege log.
